Objectives and Investment Policy

- The investment objective of the Fund is to produce long term capital growth that reflects the investment performance of the overall global equity markets while adhering to certain environmental investment criteria.
- The Fund invests in a diversified portfolio of equity and equity-related securities such as depository receipts, American depository receipts, global depository receipts, single and index stock participation notes or other securities having equities as the underlying instrument i.e. equity linked notes, fully-funded equity swaps and convertible bonds, which are traded in equity markets around the globe and are issued by companies identified by TT International Asset Management Ltd (the "Investment Manager") as providing solutions to environmental problems and which the Investment Manager also believes have sound prospects for sustainable growth and represent value in the form of assets and earnings.
- The Fund will seek to invest over 50 per cent. of its assets in issuers that generate at least 50 per cent. of revenues or operating profits from activities which contribute to the solution of an environmental problem. However, the Fund may also invest up to 50 per cent. of the Net Asset Value of the Fund in companies that are making a material improvement to environmental issues but whose revenues or operating profits from such activities do not yet account for 50 per cent. of such companies' business.
- The main environmental themes targeted will be in the following sectors: (i) clean energy; (ii) clean transport; (iii) forestry and agriculture; (iv) responsible consumption; (v) recycling and circular economy; (vi) sustainable use and protection of water; and (vii) electrification, electrical and industrial efficiency. However, the Investment Manager will have discretion to identify additional sectors that contribute to the solution of an environmental problem.
- Up to 20 per cent. of the Net Asset Value of the Fund may be invested in cash and cash equivalent assets (which may include Money Market Instruments) where, by way of example, it is necessary to support financial derivative instrument ("FDI") exposure or where in view of market conditions the Investment Manager may seek to adopt a defensive investment strategy.

- The Fund may buy and sell futures and options (comprising options on futures, options on equity indices and exchangetraded funds and stock options) in pursuit of the investment objective and to gain exposure to the instruments listed above as well as for efficient portfolio management purposes.
- The Fund may participate in initial public offerings of the equity and equity-related securities listed above.
- The convertible bonds in which the Fund invests will be issued by corporates worldwide and may be fixed and floating rate and noninvestment grade. Non-investment grade debt securities are debt securities that are rated BB+ or lower by a rating agency, or are unrated but determined by the Investment Manager to be of comparable quality.
- Up to 10 per cent. of its Net Asset Value of the Fund may be invested in certain collective investment schemes.
- Recommendation: due to the entry charge and exit charge which may be payable on the issuance and repurchase of Shares, an investment in the Fund should be viewed as medium to long term.
- The Fund may use certain FDIs for hedging, investment and efficient portfolio management purposes.
- The performance of the Fund may be strongly influenced by movements in foreign exchange rates.
- The Fund is actively managed. It uses the MSCI ACWI Index (the "Benchmark Index") as "comparator benchmark" against which to compare the performance of the Fund. The Benchmark Index does not take into account environmental, social and governance factors and has not been designated for the purposes of attaining the sustainable investment objective of the Fund.
- You may buy and sell Shares on any day on which banks are open for business in Dublin and London.
- The Class B6 Shares are a distributing share class and the Directors are entitled to declare dividends out of the Fund.

- FDI Risk: FDI may fluctuate in value rapidly and leverage through FDI may cause losses that are greater than the original amount paid for the relevant FDI.
- Operational Risk: human error, system and/process failures, inadequate procedures or control may cause losses to the Fund.
- Liquidity Risk: the Fund may have difficulty buying or selling certain securities readily which may have a financial impact on the Fund.
- Credit/Counterparty Risk: a party with whom the Fund contracts for securities may fail to meet its obligations (e.g. fail to pay principal or interest or to settle an FDI) or become bankrupt, which may expose the Fund to a financial loss.
