## GBP “Class C1” Shares of TT European Opportunities Long/Short Fund (the “Fund”) (ISIN: IE00BJ7W3N57)

### A Share Class of a sub-fund of TT International Funds plc (the “Company”)

The Company is managed by Carne Global Fund Managers (Ireland) Limited (the “Manager”).

#### Objectives and Investment Policy

- The investment objective of the Fund is to produce long term capital growth.
  - The Fund is actively managed and invests in a diversified portfolio of both long and synthetic short positions primarily in equity and equity-related securities predominately traded in the European region.
  - Under normal market conditions, the Fund will predominately invest in equity or equity-related securities including common stock, preferred stocks, depositary receipts, options, CFDs, swaps, warrants and convertible debt securities including non-investment grade debt securities (not more than 10 % of the Net Asset Value of the Fund may be invested in non-investment grade debt securities).
  - Up to 20 % of the Net Asset Value of the Fund may be invested in equity and equity-related securities listed globally which TT International Asset Management Ltd (the “Investment Manager”) believes have sound prospects for sustainable growth and represents value in the form of assets and earnings in order for the Fund to meet its investment objective.
  - The Fund may take both long and short positions and such positions are expected to be within a net range of 60 % long and maximum -30 % short of the Net Asset Value of the Fund.
  - Short positions are taken through: futures (including index futures), options (including stock options, options on futures, indices and ETFs), foreign exchange spot and forwards, CFDs and swaps which may provide exposure to any type of security in which the Fund is permitted to invest.
  - The Fund may be invested up to 100 % of its Net Asset Value in cash and cash equivalent assets (which may include Money Market Instruments) where, by way of example, it is necessary to support financial derivatives instruments (“FDI”) exposure or where in view of market conditions the Investment Manager may seek to adopt a defensive investment strategy.
  - The Fund may participate in initial public offerings of equity and equity-related securities listed above.
  - Up to 10 % of the Net Asset Value of the Fund may be invested in certain collective investment schemes.
  - Recommendation: due to the entry charge and exit charge which may be payable on the issue and repurchase of shares, an investment in the Fund should be viewed as medium to long term.
  - The Fund may use certain FDI for hedging, investment and efficient portfolio management purposes. The performance of the Fund may be strongly influenced by movements in foreign exchange rates.
  - Under normal market conditions, the Fund envisages employing leverage of between 80 % and 200 % but it may exceed or fall below these levels at times.
  - The Investment Manager may make discretionary choices when deciding on which investments should be held by the Fund, subject to the Fund’s investment objective, policy and restrictions.
  - You may buy and sell shares on any day on which banks are open for business in Dublin and London.
  - The Class C1 Shares are an accumulation share class and the net income attributable to the shares shall be retained within the Fund and the value of the shares shall rise accordingly.

The Synthetic Risk and Reward Indicator (“SRRRI”) table above shows how the Fund ranks in terms of potential risk and return. It is not a measure of the risk of capital loss but is essentially a measure of the previous ups and downs in value of the Fund.

Please note that:

- historical data used in calculating the SRRRI may not be a reliable indication for how the Fund will perform in the future.
- the risk category shown is not guaranteed to remain unchanged and may shift over time.
- even the lowest category does not mean your investment is ‘risk free’.

The SRRRI of the Fund is ranked at 4. The Fund is in category 4 because of the high range and frequency of price movements (volatility) of the underlying investments referenced by the Fund. The following are risks materially relevant to the Fund which are not adequately captured by the SRRRI:

- **FDI Risk:** FDI may fluctuate in value rapidly and leverage through FDI may cause losses that are greater than the original amount paid for the relevant FDI.
- **Operational Risk:** human error, system and/process failures, inadequate procedures or control may cause losses to the Fund.
- **Liquidity Risk:** the Fund may have difficulty buying or selling certain securities readily which may have a financial impact on the Fund.
- **Credit/Counterparty Risk:** a party with whom the Fund contracts for securities may fail to meet its obligations (e.g. fail to pay principal or interest or to settle an FDI) or become bankrupt, which may expose the Fund to a financial loss.
