Objectives and Investment Policy

- The investment objective of the Fund is to produce long-term capital growth.
 - The Fund invests in a diversified portfolio of primarily equity and equity-related securities traded in Europe excluding the United Kingdom.
 - Under normal market conditions, the Fund will invest at least 80 % of its Net Asset Value in equity or equity-related securities traded on the exchanges of some or all of the countries included in the MSCI Europe Ex-UK Index (the “**Benchmark Index**”), including common stock, preferred stocks, warrants (not more than 5 % of the Net Asset Value of the Fund) and convertible debt securities including non-investment grade debt securities (not more than 5 % of the Net Asset Value of the Fund may be invested in such debt securities).
 - In addition, up to 5 % of the Net Asset Value of the Fund may be invested in equity securities listed or traded on level 1 or level 2 of the Moscow Exchange in Russia.
 - The Fund may participate in initial public offerings of the equity and equity-related securities listed above.
 - Up to 10 % of the Net Asset Value of the Fund may be invested in certain collective investment schemes.
 - The Fund may use certain financial derivatives instruments (FDI) for hedging, investment and efficient portfolio management purposes. The performance of the Fund may be strongly influenced by movements in foreign exchange rates.
 - Recommendation: due to the entry charge and exit charge which may be payable on the issue and repurchase of shares, an investment in the Fund should be viewed as medium to long term.
 - The Fund is actively managed. It uses the Benchmark Index to assist in the determination of the universe from which to select securities as outlined above, as a target to outperform and/or for future performance comparison purposes in marketing literature. TT International (or any successor entity serving as investment manager of the Fund identified in the Prospectus (the “**Investment Manager**”)) may make discretionary choices when deciding which investments should be held by the Fund, subject to the Fund’s investment objective, policy and restrictions.
 - You may buy and sell shares on any day on which banks are open for business in Dublin and London.
 - The Class L Shares are an accumulating share class and the net income attributable to the Shares shall be retained within the Fund and the value of the Shares shall rise accordingly.

The Synthetic Risk and Reward Indicator (SRRI) table above shows how the Fund ranks in terms of potential risk and return. It is not a measure of the risk of capital loss but is essentially a measure of the previous ups and downs in value of the Fund. Please note that:

- historical data used in calculating the SRRI may not be a reliable indication for how the Fund will perform in the future.
- the risk category shown is not guaranteed to remain unchanged and may shift over time.
- even the lowest category does not mean your investment is ‘risk free’.
- investing in Russian based securities involves additional risks (including but not limited to, Political and Economic Risks, Commercial and Credit Risks, Liquidity risks, Legal and Regulatory Risks, Counterparty Risk and Operational Risks).
- there are risks associated with the financial and economic crisis affecting the European Monetary Union.

The SRRI of the Fund is ranked at 5. The Fund is in category 5 because of the high range and frequency of price movements (volatility) of the underlying investments referenced by the Fund.

The following are risks materially relevant to the Fund which are not adequately captured by the SRRI:

- **Credit/Counterparty Risk:** a party with whom the Fund contracts for securities may fail to meet its obligations (e.g. fail to pay principal or interest or to settle an FDI) or become bankrupt, which may expose the Fund to a financial loss.
- **Liquidity Risk:** the Fund may have difficulty buying or selling certain securities readily which may have a financial impact on the Fund.
- **FDI Risk:** FDI may fluctuate in value rapidly and leverage through FDI may cause losses that are greater than the original amount paid for the relevant FDI.
- **Operational Risk:** human error, system and/process failures, inadequate procedures or control may cause losses to the Fund.
