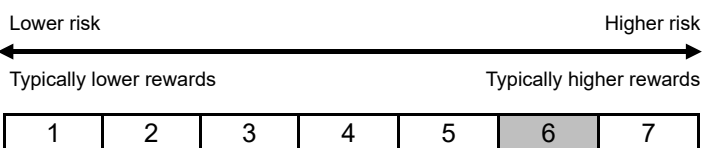
## USD "Class A1" Shares of TT Global SMID-Cap Equity Fund (the "Fund") (ISIN: IE0006MUY0J6) A Share Class of a sub-fund of TT International Funds Plc (the "Company"). The Company is managed by Carne Global Fund Managers (Ireland) Limited (the "Manager").

### Objectives and Investment Policy

- The investment objective of the Fund is to produce long-term capital growth.
- The Fund is actively managed and invests in a diversified portfolio of primarily equity and equity-related securities of small and mid-capitalisation companies traded in equity markets around the globe, which TT International Asset Management Ltd (the "Investment Manager") believes to be high quality with exposure to structural growth drivers within certain global themes and represent value in the form of assets and earnings. The Investment Manager will focus on the following global themes when identifying companies: 1) Environmental; 2) Technological; 3) Demographic and Sociological; and 4) Top Down and Opportunistic.
- Under normal market conditions the Fund will invest at least 80% of the Net Asset Value of the Fund in (i) equity or equity-related securities of companies included in the MSCI ACWI SMID Cap Index (the "Benchmark Index"), and/or (ii) in equity or equity related securities of companies which are not included in the Benchmark Index, but where the issuer in question has its registered office, or domicile, located in, or in the opinion of the Investment Manager, exercise the majority of their economic activity in the countries of the Benchmark Index and/or (iii) in equity or equity-related securities traded, or for which the underlying securities are traded, on the exchanges of the countries included in the Benchmark Index (including common and preferred stocks, warrants and fixed and floating rate convertible and hybrid fixed-income debt securities including non-investment grade debt securities of corporate and government issuers worldwide (not more than 5% of the Net Asset Value of the Fund may be invested in such securities)). Non-investment grade debt securities are debt securities that are rated BB+ or lower by a rating agency, or are unrated but determined by the Investment Manager to be of comparable quality.
- The Fund may invest in depositary receipts, American depositary receipts, global depositary receipts, single and index stock participation notes or other securities having equities as the underlying instrument, i.e., equity linked notes (not containing embedded derivatives), and fully funded equity swaps, which are, or for which the underlying securities are, traded in equity markets around the world and which the Investment Manager believes have sound prospects for sustainable growth and represent value in the form of assets and earnings.
- The Fund promotes environmental and/or social characteristics by investing a minimum of 80% of its assets in companies that the Investment Manager believes contribute to the UN Sustainable Development Goals also adopt a UN Global Compact violations filter so that any company that has grave and ongoing violations of the principles with no rectification plan will not form a part of the Fund's portfolio.
- The Fund will exclude companies that derive more than 10% of their revenues from fossil fuels and related sectors, tobacco, cannabis, alcoholic beverages, gambling, weapons, and adult entertainment.
- The Fund may buy and sell futures and options (comprising options on futures, options on equity indices and exchange traded funds and stock options) in pursuit of the investment objective and to gain exposure to the instruments listed above as well as for efficient portfolio management purposes.
- The Fund may participate in initial public offerings of the equity and equity-related securities listed above.
- Up to 10% of the Net Asset Value of the Fund may be invested in certain collective investment schemes.
- The Fund may use certain financial derivatives instruments ("FDI") for investment, hedging and efficient portfolio management purposes.
- The performance of the Fund may be strongly influenced by movements in foreign exchange rates.
- The Fund uses the Benchmark Index to assist in the determination of the universe from which to select securities as outlined above, as a target to outperform and/or for future performance comparison purposes in marketing literature. The Investment Manager may make discretionary choices when deciding which investments should be held by the Fund, subject to the Fund's investment objective, policy and restrictions.
- You may buy and sell shares on any day on which banks are open for business in Dublin and London.
- The Class A1 Shares are an accumulation share class and the net income attributable to the shares shall be retained within the Fund and the value of the shares shall rise accordingly.

### Risk and Reward Profile



The Synthetic Risk and Reward Indicator ("SRRI") table above shows how the Fund ranks in terms of potential risk and return. It is not a measure of the risk of capital loss but is essentially a measure of the previous ups and downs in value of the Fund.

Please note that:

- historical data used in calculating the SRRI may not be a reliable indication for how the Fund will perform in the future.
- the risk category shown is not guaranteed to remain unchanged and may shift over time.

- investing in small and mid-capitalisation companies traded in equity markets around the globe involves additional risks and special considerations not typically associated with investing in other more established economies or securities markets (including, less liquidity and operational risks).

The SRRI of the Fund is ranked at 6. The Fund is in category 6 because of the high range and frequency of price movements (volatility) of the underlying investments referenced by the Fund.

The following are risks materially relevant to the Fund which are not adequately captured by the SRRI:

- FDI Risk:** FDI may fluctuate in value rapidly and leverage through FDI may cause losses that are greater than the original amount paid for the relevant FDI.
- Operational Risk:** human error, system and/process failures, inadequate procedures or control may cause losses to the Fund.
- Liquidity Risk:** the Fund may have difficulty buying or selling certain securities readily which may have a financial impact on the Fund.
- Credit/Counterparty Risk:** a party with whom the Fund contracts for securities may fail to meet its obligations (e.g. fail to pay principal or interest or to settle an FDI) or become bankrupt, which may expose the Fund to a financial loss.

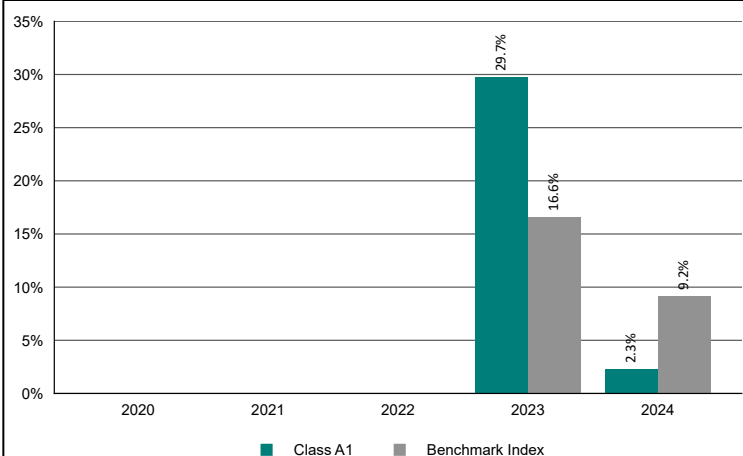
