**Objectives and Investment Policy**

<ul style="list-style-type: none"><li>• The investment objective of the Fund is to produce long-term capital growth.</li><li>• The Fund invests in a diversified portfolio of primarily equity and equity-related securities traded in the United Kingdom.</li><li>• Under normal market conditions, the Fund will invest at least 80% of its Net Asset Value in equity or equity-related securities traded on the exchanges included in the FTSE All Share Index (the "<b>Benchmark Index</b>"), including common stock, preferred stocks, warrants (not more than 5% of the Net Asset Value of the Fund) and convertible debt securities including non-investment grade debt securities (not more than 5% of the Net Asset Value of the Fund may be invested in such securities). Non-investment grade debt securities are debt securities that are rated BB+ or lower by a rating agency, or unrated but determined by TT International Asset Management Ltd (the "<b>Investment Manager</b>") to be of comparable quality. It is acknowledged that this may include equity or equity-related securities that are dual listed, which means they will be traded on the exchanges included in the Benchmark Index as well as other exchanges as set out in the Prospectus.</li><li>• The Fund may participate in initial public offerings of the equity and equity-related securities listed above. The Benchmark Index is an index of common stocks of companies domiciled in the United Kingdom.</li></ul>	<ul style="list-style-type: none"><li>• Up to 10% of the Net Asset Value of the Fund may be invested in certain collective investment schemes.</li><li>• The Fund may use certain financial derivatives instruments ("<b>FDI</b>") for hedging, investment and efficient portfolio management purposes. It uses the Benchmark Index to assist in the determination of the universe from which to select securities as outlined above, as a target to outperform and/or for future performance comparison purposes in marketing literature.
