# Purpose

This document provides you with key information about this investment product. It is not marketing material. The information is required by law to help you understand the nature, risks, costs, potential gains and losses of this product and to help you compare it with other products.

The Fund is authorised in Ireland and regulated by the Central Bank of Ireland. The key information document is accurate as at 31 March 2024.

The Fund is managed by Carne Global Fund Managers (Ireland). Imited (the "Manager") which is authorised in Ireland and regulated by the Central Bank of Ireland. TT International Asset Management Ltd (the "Investment Manager") has been appointed as investment manager to the Fund.

You are about to purchase a product that is not simple and may be difficult to understand.

# > What is this product?

Type: This Fund is a UCITS.

Term: No fixed term.

Objectives: The investment objective of the Fund is to produce long-term capital growth.

The Fund is actively managed. It uses the Benchmark Index to assist in the determination of the universe from which to select securities as outlined above, as a target to outperform and/or for future performance comparison purposes in marketing literature. The Investment Manager may make discretionary choices when deciding which investments should be held by the Fund, subject to the Fund's investment objective, policy and restrictions

The Fund invests in a diversified portfolio of primarily equity and equity-related securities such as depository receipts, American depository receipts, global depository receipts, single and index stock participation notes, other securities having equities as underlying instrument (i.e. convertible bonds) or warrants which are or for which the underlying securities: (i) are listed or traded on the MSCI China Index (the "Benchmark Index"); (ii) are listed on a Market (as defined in the Prospectus) and (a) has its registered office or domicile located in countries listed in the Benchmark Index; or (b) does not have its registered office or domicile located in countries listed in the Benchmark Index; from countries located in the Benchmark Index. The Benchmark Index. The Benchmark Index captures the equity market performance of large and mid-cap China securities and non-domestic China securities traded on Chinese, Hong Kong and other foreign exchanges.

The Fund may buy options, such as options on futures and options on equity indices and ETFs, up to a value of 10% of its Net Asset Value

The Fund may participate in initial public offerings of the equity and equity-related securities listed above

Up to 10% of the Net Asset Value of the Fund may be invested in certain collective investment schemes.

The Fund may also obtain exposure directly to China via Stock Connect but will not invest directly in China Class A Shares.

The Fund may also be invested in equity and equity-related securities listed globally which may not fulfil the criteria outlined above.

The Fund may also invest up to 10% of its Net Asset Value in non-investment grade debt securities of corporate and government issuers worldwide. Non-investment grade debt securities are debt securities that are rated BB+ or lower by a rating agency, or are unrated but determined by TT International Asset Management Ltd to be of comparable quality.

You may sell your shares on any day on which banks are open for business in Dublin and London.


The Fund may be terminated at any time upon prior notice to the Shareholders.

# What are the risks and what could I get in return?



The risk indicator assumes you keep the product for 5 years.

# > What happens if Carne Global Fund Managers (Ireland) Limited is unable to pay out?

# > What are the costs?

#### Costs over time

# > How long should I hold it and can I take my money out early?

#### The recommended minimum holding period: 5 years.

The Fund is designed to be held over the medium to long term and we recommend that you hold this investment for at least 5 years.

You can request to take out some or all of your money at any time. You can typically request to buy or sell shares in the sub-fund on any business day (as set out in the Fund's prospectus).

If you cash in at an early stage this will increase the risk of lower investment returns or a loss.
